Notification No. (7/2017)

Nay Pyi Taw, The 13th Waning Day of Pyathol, 1378 M.E.
(25 January 2017)

In exercise of the powers conferred under subsection (a) of section 48 of the Fertilizer Law, the Ministry of Agriculture, Livestock and Irrigation hereby issues the following procedures with the approval of the Union Government.

1. These procedures shall be called the Procedures Amending the Procedures relating to the Fertilizer Law.
2. The expression “Managing Director” contained in the Procedures relating to the Fertilizer Law shall be substituted by the expression “Director General”.
3. Subparagraphs (c), (d), (e) and (f) of paragraph 2 of the Procedures relating to the Fertilizer Law shall be deleted.
4. The paragraph 20 of the Procedures relating to the Fertilizer Law shall be substituted as mentioned below:
 - (a) Fertilizer productions on Form (1), Fertilizer export on Form (2) and Fertilizer import on Form (3) shall be used for application.
 - (b) Regarding to the fertilizer mixed with herbicide, when applying for the fertilizer registration certificate, the approval of certificate proving that the herbicide is already registered in accordance with the relevant law is necessary and it shall be attached to the relevant form mentioned in the paragraph (a) and submitted to the Fertilizer Committee.
5. The expressions “paragraph 22” contained in paragraph 24, “paragraph 21” contained in paragraph 25, “paragraph 21” contained in paragraph 26 of the Procedures related to the Fertilizer Law shall be substituted by the expression “paragraph 23” respectively.

6. After paragraph 27 (d) in the Procedure relating to the Fertilizer Law, sub paragraph 27 (e) shall be added as follows:

“(e) The inspector body shall be built up their capacity by providing trainings and workshops.”

7. Subparagraph (f) of paragraph 28 contained in the Procedure relating to the Fertilizer Law shall be substituted as follows:

“(f) only the products with true labeling which already permitted by the Fertilizer Committee are allowed to advertise and sell and not allowed to advertise with wrong messages concerned with the quality and specification of the products.

8. Paragraph 29 of the Procedure relating to the Fertilizer Law shall be substituted as follows:

(a) “A person desirous of carrying on (or) conducting storage fertilizers shall apply for storage license”

9. In paragraph 37 of the Procedure relating to the Fertilizer Law:

(a) subparagraph (b) shall be substituted as follows:

(a) “(b) store and distribute only fertilizer mentioned in the certificate.

(b) subparagraph (c) shall be substituted as follows:

“(c) Shall abide by the provisions of the existing Laws regarding to the workers’ health and social welfare

when carrying on conducting storage business in Myanmar.”

(c) subparagraph (d) shall be deleted.

(d) subparagraph (g) shall be substituted as follows:

“(g) mention the following points on the packages or bags:

(1) Registration numbers of import, export and production

(2) Logo or Label

(3) Net weight

(4) Quality assurance

(5) Percentage of the nutrients contained in the fertilizer

(6) Name of Manufacturer (Companies, Business, Organization), Location, Production date and expired date and storage system

(7) Prescriptions for use and precautions mentioned in Myanmar language

(8) No harmful substances to human and environment

- (e) the expression “for the inspection under paragraph 12” mentioned in subparagraph (j) shall be deleted.
10. Paragraph 38 of the Procedure relating to the Fertilizer Law shall be deleted.
11. Paragraph 42 of the Procedure relating to the Fertilizer Law shall be substituted as follows;
- “42. When the Director General finds the fertilizer does not conform with the specification, he shall report it to the Fertilizer Committee urgently.”
12. Paragraph 53 of the Procedure relating to the Fertilizer Law shall be substituted as follows;
- “(a) Fertilizer samples shall be analyzed only at the Laboratory recognized by the Fertilizer Committee.”
- (b) Regarding to analyzing under paragraph 12 (a), the analytical result shall be approved in Form (17) by Director of Land Use Division and given each copy to relevant officer or inspector body and sample owner.
- (c) Director of Land Use Division shall report urgently to the Director General when he finds the fertilizer does not conform with the specification.

(d) If a dispute on analytical results occurs, the decision based on the analytical result of the Land Use Division, Department of Agriculture shall be final and conclusive.

13. The expression “Myanma Agriculture Service” contained in paragraph 55 of the Procedure relating to the Fertilizer Law shall be substituted by the expression “the Authorized person or Body from Department of Agriculture”.

14. Paragraph 57 of the Procedure relating to the Fertilizer Law shall be substituted as follows:

“57. The Fertilizer Committee shall:

(a) inspect fertilizers not to import prohibited fertilizers to Myanmar

(b) form and assign subcommittees at the Border Trade Stations for inspection processes mentioned in paragraph 57 (a).”
